



# Cooperation Agreement

between

**European Aviation Maintenance Training Committee – EAMTC**

and

**International Association of Aviation Personnel Schools – IAAPS**

This Cooperation Agreement (hereinafter referred to as “Agreement”) is made effective as of 01,01, 2022 by and between

(Hereinafter referred to as “IAAPS”)

Now, therefore, the parties agree as follows:

#### **1. SCOPE OF THE AGREEMENT**

EAMTC and IAAPS agree to cooperate closely in all areas of training, e.g. development, methods, delivery and assessment, as well as representing their members towards national, European and international authorities and stakeholder.

Both parties will perform their cooperation based on results of working meetings between their chairperson, president or other representatives authorized by the board or executive committee of IAAPS and EAMTC.

The EAMTC president and the IAAPS chairperson or the authorized representatives will develop further details of cooperation projects in regular meetings and share the results with the members.

Cooperation projects will be documented and are available to both organisations.

## 2. TERM

This Agreement will enter into force on the date first above written and remain valid for **24 months thereafter** (initial period). Unless terminated by either party giving notice to the other party not less than 3 months prior to the end of the initial period, this Agreement shall be automatically renewed for an additional period of 12 months.

Should the Agreement be terminated by either Party both Parties shall assess the status of all open projects and their related financial impact and shall mutually agree on a fair settlement.

## 3. LIABILITIES

Each party shall indemnify and hold harmless the other party, its employees, officers and members from and against any loss, cost, damage, claim, expense or suit against them resulting from or in connection with its gross negligence or wilful misconduct in providing the services under this Agreement.

Each party shall indemnify and keep indemnified the other party, its employees, officers and members from and against any loss, cost, damage, or expense suffered by a party as a result of a third party claim or suit in any way connected with alleged faults or deficiencies in respect of any decisions, publications or information provided under this Agreement.

## 4. NOTICES

All notices required or permitted under this Agreement shall be in writing and shall be deemed delivered in person or sent by registered mail, postage prepaid, fax or e-mail (with explicit read receipt) addressed as follows:

This Agreement contains the entire agreement of the parties and there are no other promises or conditions in any other agreement whether oral or written. This Agreement supersedes any prior written or oral agreement between the parties.

## 6. AMENDMENTS

This Agreement may be modified or amended only if the amendment is made in writing and signed by both parties.

**7. APPLICABLE LAW AND COURT**


**Regarding jurisdiction, the parties agree to revert to out-of-court settlement by using a mechanism of a Joint Management Team Resolution panel before starting legal procedures.**

However, if any party commences legal proceedings under this Agreement, this Agreement shall be governed construed and interpreted in accordance with the laws of the jurisdiction of Netherlands.


